Ravencoin Market Summary and & Outlook

Weekly Summary:

- Ravencoin is flat for the week from \$0.052 to \$0.052. RVN
- 4.13.22 weekly high trading over ~\$19.43 million in volume in this 24-hour period
 - ↓\$0.5M from last week's rally.
- Binance saw the majority of this volume traded around ~\$9.2M followed by at ~\$3.8M OKX and Pionex ~\$3.0M
 - Bittrex at ~\$81.7K (UMG Trading Exchange)

Short Term Drivers:

- Ravencoin dropped in overall market capitalization from 117week prior to 118
 - RVN Market Cap 574M 4.17.22
 - ↓ 43M week-over-week
- RVN is seeing day after day decrease this week to finish the week up RVN is now trending **bearish** as the new week starts.

Long Term Drivers:

- Ethereum moving to Proof-of-stake ETA June 2022
 - New home for GPU mining
- RVN Experienced its first halving in January of 2022. Block reward reduced from 5,000 to 2,500
 - Reduced supply by 3.6M RVN/Day
- RVN circulating supply around ~10.4B/21B

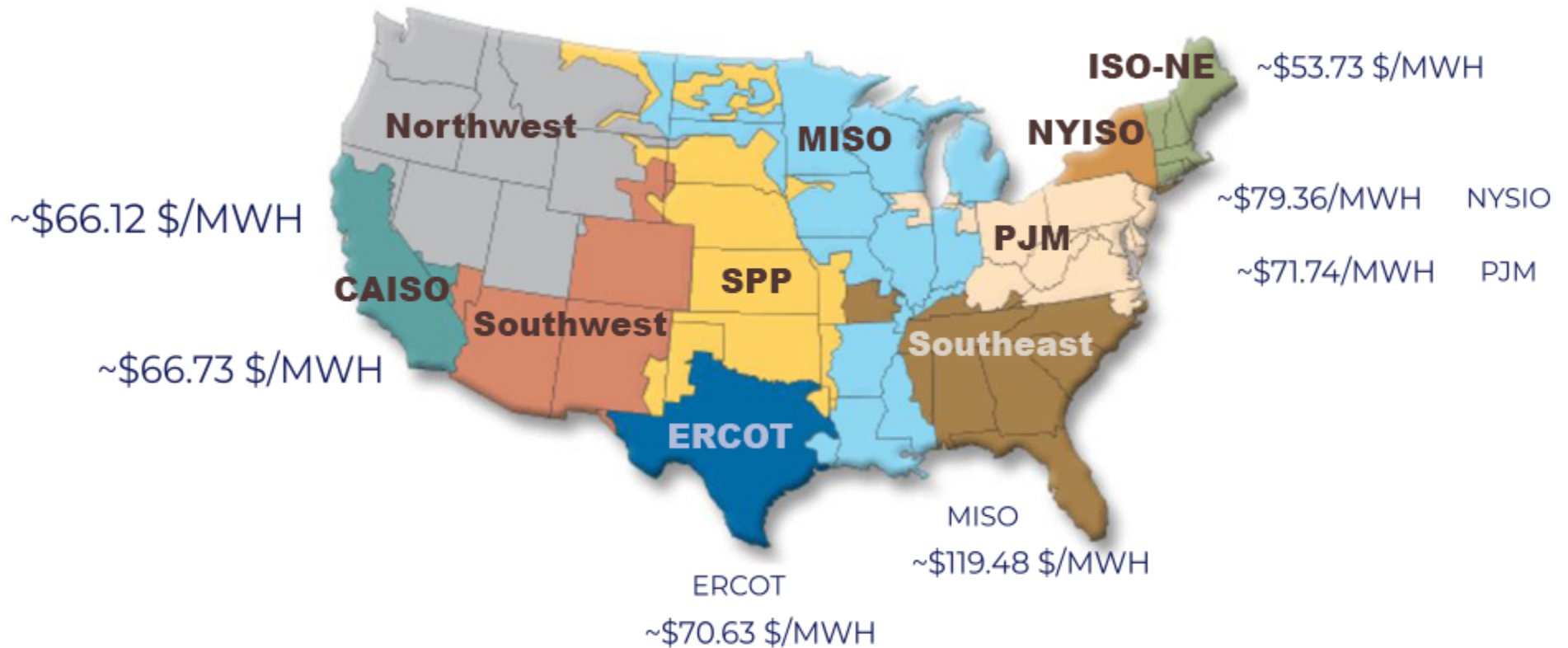
Seven Day Price History [[CoinMarketCap](#)]

Regional Power Prices On-Peak Estimates 4.17.22

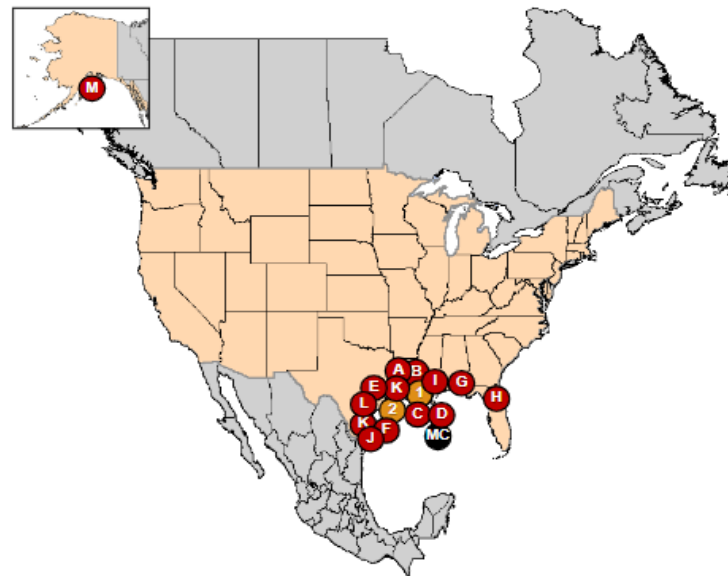

Natural Gas Market Highlights

- NYMEX Futures trading above \$9.50/Dth for Winter Strip 22-23; ↑ from prior week \$1.50/Dth
 - Bullish for the year
- LNG at max export capacity
 - New Terminals coming on-line 2023
- April 2022 forecasted warmer than normal
- Storage Inventories below 2-Year Average
- Biden announced tapping into the strategic oil reserves, NG prices continue to rise
- Biden announced opening of land-lease into drilling - this will take at least 6 months to have impact on supply
